Significant Accounting Policies for the Preparation of Financial Statements

1. Valuation method of securities

Investments in securities of subsidiaries and affiliates are valued at cost, determined using the moving-average method.

Available-for-sale securities are classified into two categories: (i) fair value is available and (ii) fair value is not available.

- Securities, whose fair value is available, are valued at the quoted market price prevailing at the end of the fiscal year. Net unrealized gains or losses on these securities are reported as a separate component of the shareholder's equity at a net-of-tax amount. Cost of sales is determined by the moving-average method.
 (Note) Parent company's stock is valued at cost, determined by the moving-average method, because the
 - Company was split-up and merged with the parent company on March 1, 2006 and parent company's stock became treasury stock of the parent company.
- (ii) Securities, whose fair value is not available, are valued at cost, determined by the moving-average method.
- 2. Valuation method of derivatives Derivative financial instruments are valued at fair value.

Fresh foods:	Cost, being determined by the last purchase price method.
Merchandise at stores (except fresh foods):	The lower of cost or market, cost being determined by the retail method.
Merchandise at distribution centers	
(except fresh foods):	Cost, being determined by the moving average method.
Supplies:	Cost, being determined by the last purchase price method.

(1) Property and equipment

Depreciation expenses are computed using the declining-balance method, at rates based on the estimated useful lives of assets.

(2) Intangible assets

Amortization expenses for intangible assets are computed using the straight-line method. Software is amortized using the straight-line method over an estimated useful life of 5 years.

5. Accounting for deferred assets

Bond issue costs were expensed when incurred.

6. Allowances

(1) Allowance for doubtful accounts

An allowance for doubtful accounts is provided against potential losses on collection at an amount measured using a historical bad debt ratio for normal receivables, plus an amount individually measured on the collectibility of receivables that are expected to be uncollectible due to bad financial condition or insolvency.

(2) Allowance for bonuses to employees

An allowance for bonuses to employees is provided at the amount expected to be paid in respect of the calculation period ended on the balance sheet date.

(3) Accrued pension and severance costs

An allowance for accrued pension and severance costs is provided at the amount incurred during the fiscal year, which is based on the estimated present value of the projected benefit obligation less the estimated fair value of the plan assets at the end of the fiscal year. The excess of the estimated fair value of the plan assets over the estimated present value of projected benefit obligation adjusted by unrecognized actuarial differences is recognized as prepaid pension cost for the fiscal year ended February 28, 2006. Unrecognized actuarial differences are amortized on a straight-line basis over the period of 10 years from the next year in which they arise. Prior service costs are amortized on a straight-line basis over the period of 5 years.

(4) Allowance for retirement benefits to directors and corporate auditors

An allowance for retirement benefits to directors and corporate auditors is provided in accordance with the Company's internal policy.

(5) Allowance for sales promotion

An allowance for sales promotion is provided for the use of points given to customers at the amount expected to be used on the balance sheet date in accordance with the sales promotion point card program.

7. Foreign currency translation for major assets and liabilities denominated in foreign currencies

All monetary assets and liabilities denominated in foreign currencies are translated into yen at a spot rate prevailing at the end of the fiscal year. Resulting translation gains or losses are charged or credited to income.

8. Lease

All finance lease contracts other than those by which the ownership of the leased assets is to be transferred to lessees are accounted for as operating leases.

9. Hedge accounting

The interest rate swaps which qualify for hedge accounting and meet specific matching criteria are not measured at market value but the differential paid or received under the swap agreements are recognized and included in interest income or expense as incurred.

10. Accounting for consumption taxes

Consumption taxes are separately accounted for, and are excluded from the amounts of the underlying income and expense transactions.

Additional Information

The Corporation Size-based Enterprise Tax system was effective from fiscal year beginning on or after April 1, 2004. For the year ended February 28, 2006, a corporation size-based enterprise tax was recorded as selling, general and administrative expenses, in accordance with the "Disclosure on the Statement of Income for the Corporation Size-based Enterprise Tax" (Practical Issues Task Force Report No.12, February 13, 2004, issued by Accounting Standards Board in Japan).

As a result, selling, general and administrative expenses increased by 1,686 million yen and operating income, ordinary income and income before income taxes decreased by 1,686 million yen, respectively

2. Accounting for Impairment of Fixed Assets

The Company groups its fixed assets by store which is the minimum cash-generating unit.

The book value of stores whose land had significantly depreciated, or which incurred consecutive operating losses, were reduced to recoverable amounts, and the amount written down was recorded as impairment loss in special losses.

In the case where net selling prices were used as recoverable amounts, relevant assets were evaluated based on real estate appraisal standards, and in the case where values in use were used as recoverable amounts, relevant assets were evaluated by discounting estimated future cash flows to which the 3.1% discount rate was applied.

(Subsequent events)

In accordance with the resolutions approved at meeting of the board of directors held on January 10 and 24, 2006 and at the extraordinary shareholders' meeting held on January 25, 2006, the Company changed its name to Ito-Yokado SHC Co., Ltd. and transferred superstore business and function of controlling its group companies to a newly established company on March 1, 2006.
