2. Appointment of Chairperson of the Board (Gicho) and Lead Independent Outside Director

(1) Background

Since May 2022, the Company has designated a Lead Independent Outside Director, with the aim of further enhancing the effectiveness of the Board of Directors' supervisory function by fulfilling the following roles. This decision was based on the fact that, since that time, the majority of the Board of Directors has consisted of outside directors with diverse experience and expertise. <The role of the Lead Independent Outside Director>

- (a) Ensuring mutual collaboration and follow-up among outside directors
- (b) Further enhancing and ensuring coordination and communication between outside directors and senior management
- (c) Strengthening collaboration between outside directors and the Audit & Supervisory Board
- (d) Promoting "constructive dialogue with shareholders and investors" involving outside directors

In addition, in May 2024, the Company resolved to separate the roles of Chairperson of the Board of Directors and CEO, aiming to (i) strengthen the corporate governance structure, (ii) enhance transparency and objectivity in management decision making, and (iii) improve the effectiveness of corporate strategy and management efficiency. Mr. Dacus, the Lead Independent Outside Director, currently serves as Chairperson of the Board (Gicho).

In conjunction with the appointment of Stephen Hayes Dacus as the Company's CEO (as announced in Notice of Change in Representative Director, March 6, 2025*), the Board of Directors has discussed the appointment of his successor and, based on the reasons for selection below, has resolved to appoint Fuminao Hachiuma to the position.
