Bureau Veritas Japan Co., Ltd. (Bureau Veritas) was engaged by Seven & i Holdings Co., Ltd. to conduct an independent verification of the greenhouse gas (GHG) emissions reported by Seven & i Holdings Co., Ltd. in its Sustainability Data Book 2025.

## 1. Scope of Verification

Seven & i Holdings Co., Ltd. requested Bureau Veritas to verify, to a limited level of assurance, the accuracy of the following GHG information:

### 1) Scope 1 and Scope 2 emissions:

- CO<sub>2</sub> emissions from energy use through the following store operations within Japan, U.S.A (excluding stores operated by domestic licensees of 7-Eleven, Inc.) and Canada:

- CO<sub>2</sub> emissions from energy use through the operations of five factories of York-Benimaru Co., Ltd. within Japan for the period of April 1, 2024 through March 31, 2025
- CO<sub>2</sub> emissions from energy use through the operations of four factories of K.K.Peace Deli within Japan for the period of April 1, 2024 through March 31, 2025
- CO<sub>2</sub> emissions from energy use through the operations of four offices (including the head office) and three directly-operated ATMs of Seven Bank, Ltd. for the period of April 1, 2024 through March 31, 2025
- CO<sub>2</sub> emissions from energy use through the operations of the head office and Training Center of Seven & i Holdings Co., Ltd. for the period of April 1, 2024 through March 31, 2025
- Effective September 1, 2025, Seven & i Food Systems Co., Ltd. changed its name to Denny's Japan Co., Ltd., and Seven & i Create Link Co., Ltd. changed its name to Create Link Co., Ltd.

### 2) Scope 3 Category 1 emissions:

- GHG emissions from following goods and services purchased by Seven-Eleven Japan Co., Ltd.:

## 2. Methodology

Bureau Veritas conducted the verification in accordance with the requirements of the international standard 'ISO14064-3 (2019): Greenhouse gases - Part 3: Specification with guidance for the verification and validation of greenhouse gas statements'.

As part of Bureau Veritas' assurance, the following activities were undertaken:

- Interviews with relevant personnel of Seven & i Holdings Co., Ltd. and the companies listed in "1. Scope of Verification" responsible for the identification and calculation of GHG emissions;
- Review of Seven & i Holdings Co., Ltd.'s and the companies' listed in "1. Scope of Verification" information systems and methodology for collection, aggregation, analysis and review of information used to determine GHG emissions; and
- Audit of a sample of source data to check accuracy of quantified GHG emissions.

## 3. Conclusion

Based on the verification work and processes followed, there is no evidence to suggest that the GHG emissions assertions shown below:

- are not materially correct and are not a fair representation of the GHG emissions from activities within the scope of work
- are not prepared in accordance with the methodology for calculating GHG emissions established and implemented by Seven & i Holdings Co., Ltd.
